- Reported that California has adopted NFPA Standards for PPE (10-year expiration).

Chief Gilbert requested that the board consider the possibility of hiring part-time office help and seasonal firefighters (would work 12-hour shifts, June – October). He stated that a percentage of the administrative cost reimbursement received from mutual aides could be a possible funding source. Discussion followed. Kate Dunlap and either Allen Gobel or Doug Turner will meet with Chief Gilbert and Kara Alvernaz to draft proposed budgets and job descriptions for the board to further discuss part-time office help and seasonal firefighter positions.
