Chief Gilbert reported that Janus Solar Project representatives requested to meet again. They informed that they plan to appeal the Colusa County Planning Commission decision. They requested a letter from the Authority stating that the Authority agreed to mitigation costs. Staff was directed to compose a letter stating that the Authority agreed to mitigation costs for the project but that the Authority doesn't take a position on the project.
